SUBJECT: FTA Section 5311 Funding Assistance

### **RECOMMENDATION**

Public Works requests that the Calaveras Council of Governments (CCOG) approve the programming of funds for and authorize the necessary Certifications and Assurances to complete application for U.S. Department of Transportation (DOT), Section 5311 funding for Transit Assistance.

### **DISCUSSION**

The Federal Transit Administration (FTA) Non-Urbanized Area Formula Program, commonly known as the Section 5311 Program, provides funds for public transportation projects and inter-city bus projects serving areas that are outside of an urban boundary with a population of 50,000 or less. With these funds the mobility needs of rural transit users can be both supported and met. Section 5311 Program grants are intended to provide access to employment, education, health care facilities, shopping and recreation.

In order to receive Section 5311 funding assistance for transit, Public Works must submit a resolution from the authorized Regional Transportation Planning Agency to the California Department of Transportation approving the programming of these federal funds for transit use and authorizing the CCOG Director to complete the Certifications and Assurances for the programmed funds.

### **FISCAL IMPACT**

Section 5311 funding is currently programmed for operating assistance for Calaveras Transit. The U.S. Department of Transportation has allocated \$179,713 for Calaveras County for this fiscal year. The available Section 5311 funding has already been recognized in the Transit budget for the 2006/2007 fiscal year. This funding supports operating costs and reduces the fiscal burden on Local Transportation Fund monies.
